#### Staff Reports

### Roadmaster – Lonny Jewart

Lonny Jewart reported that the salt stockpile was greatly diminished. The contract was for 120 tons and he is able to order up to 140% of the contracted amount. If the contract is fulfilled and the State does not allow any further purchase, he will purchase additional stock in accordance with the regulations set forth in the Second Class Township Code.

Duane Patten stated his opinion on the holes on Boydstown Road that he feels needs to be fixed.

#### Code Enforcement Officer, Secretary/Treasurer - Nadine Neff

A call was received from John Williams, insurance agent for the Township. EMC has notified us that the worker's compensation policy will be non-renewed because of the unknown possible losses with regards to the Volunteer Firefighters and provisions of the Firefighter Cancer Presumption Law. The Board agreed with John Williams suggestion to place the volunteer firefighters on a separate worker's compensation policy with the State insurance fund and then EMC insurance would continue to insure the township employees on a more cost friendly worker's compensation policy.

#### **Old Business**

#### St. Joe Road Stormwater Erosion Issues

Various opinions to remedy the storm water issues were discussed. **Supervisor Brian Hans** motioned to leave the pipes at 15 inches in diameter and blacktop the ditches. Lonny Jewart stated that the top two pipes are at issue and further discussion ensued. **There was no second and the motion died on the floor.** 

After further discussion, it was determined that Mike Coyle's property is most need in repair at this time. The Board directed that Nadine Neff was to give a letter to Lonny Jewart to hand deliver to Mr. Coyle. Supervisor Regis Thoma again stated that the homeowner would be responsible for the cost of the pipe and that the road crew would then install it.

#### **Township Building Repairs**

Olsen Engineering has not submitted the necessary documents to obtain the required building permit from Richardson Inspection Services.

### **Earned Income Delinquent Tax Collection**

Nadine Neff stated that she will have to put considerable hours into getting the past several years of tax returns onto the computer and into a format for Keystone Collections Group. Supervisor Brian Hans motioned that Nadine Neff can be paid her code enforcement wage on an hourly basis for the time that she has to put in to get the records straightened out; Supervisor Regis Thoma seconded the motion. ROLL CALL: The motion was approved by all present members of the Board.
